CHAPTER LEGISLATIVE COMMITTEE REPORT

In the current issue of Military Officer (November 2017) under the banner of Budget Uncertainly, we are told that "once again DoD is running on borrowed money and time. It hasn't had a stable budget in seven years, which has affected all of the services negatively"; a continuing resolution (CR) is funding the government through the first week in December. This leads us to the first issue on a list

of issues that MOAA is working towards remedying: That issue is *Sequestration*. Ever since the Budget Control Act of 2011, the military has had to make significant cuts which reduced its mission capabilities.

Another issue, as you may recall, is the "*Widow's Tax"* issue that MOAA has steadfastly been pursuing for a final resolution. Both House and Senate versions of the FY17 Defense Authorization Bill prevent the \$310 monthly allowance (SSIA) for SBP-DIC widows from expiring. But neither bill would continue previously intended increases in SSIA to make progress toward phasing out the SBP-DIC offset.

A third issue is *TRICARE fee increases*. The FY2018 national defense authorization bill negotiations are underway. The Senate's budget request includes large increases to TRICARE fees across the board.

In any event, our **Chapter Legislative Committee** (Skip Bebernitz, Chris Costigan, and Pat Piccirilli) is actively advocating for us to our Congressional representatives during their recess periods. But we need your assistance and continued support. If you are unable to volunteer on the committee, your help making phone calls, sending emails (either self-composed or MOAA-composed) or letters would be appreciated.

HIGHLIGHTED CHARITY for this issue - TOYS FOR TOTS



At our Christmas luncheon this year, we are again collecting toys for the U.S. Marine Corps Reserve Toys for Tots Program. Their mission: Collect *new, unwrapped toys* during October, November and December each year, and distribute those toys as Christmas gifts to less fortunate children in Albany, Broome, Clinton, Essex, Fulton, Franklin, Hamilton, Montgomery, Rensselaer, Saratoga, Schenectady, Schoharie, Washington and Warren counties.

What types of toys may we donate? The program does not recommend specific toys, but suggests items appropriate for children up to age 12 and early teens. For pre-teens/teens you might consider sporting equipment/bags/balls, books, backpacks, cosmetics, purses, watch/wallet gift sets, bath gift sets, board games, radio control cars/trucks, hand-held electronics, skateboards/helmets, curling irons, hair straighteners, and hair dryers. *Please do not give realistic looking weapons or gifts with food*; as such items will NOT be distributed. THE VETERANS MIRACLE CENTER/ VETERANS RESOURCE CENTER, 10 Interstate Avenue, Albany, NY 12205 (518-486-8398)

The Center has been in existence for four years. Their purpose is to help veterans in need. They have a small "store front" about the size of an AFEES Shopette, open by appointment only 0900-1700, M - F. Veterans can "shop" to fulfill their immediate needs <u>at no charge</u>. All of the store items are brand new, not second-hand. Items include civilian casual clothes and suits, military pride clothing, down vests and coats, diapers and baby formula, Attends and catheters for adults, paper towels, and toilet paper.

Behind the "Store Front" is a warehouse. When veterans gets their first apartment or home, the VMC gives them a bed, mattress and box spring, living and dining room furniture, and pots and pans to start their next phase of life. If you know of anyone in need, please seek this organization out. This is a fantastic resource located in our backyard.

But they depend on the generosity of others. They receive a lot of material from other merchants: goods with damaged packaging or last year's design. The Center also relies on charitable monetary donations (and time) from individuals and groups. If you are in a position to contribute time or money, please give what you can.

NOTICE FROM MOAA: TRICARE CHANGES

Administrative and structural changes to the TRICARE program in the very near future will affect most beneficiaries except those using TRICARE for Life. For beneficiaries under age 65, to include active duty family members, it is time to take the required action if you need to.

There are key system transitions which necessitate modified technology adjustments to beneficiary data in the DEERS system - commonly called file transfers and new identifiers changing TRICARE Standard to the new TRICARE Select. In addition, the three current TRICARE Regions will be reduced to two, and the TRICARE contractors will be changing in both the East and West regions.

If you want to make changes to your TRICARE coverage, TRICARE officials are urging beneficiaries to do so as soon as possible.

What you need to know:

- By November 20, 2017, beneficiaries should have completed any and all enrollment actions. Beneficiaries will *not* be able to use the Beneficiary Web Enrollment website to enroll in or dis-enroll from TRICARE Prime options. Additionally, beneficiaries will *not* be able to use the web enrollment to enroll in TRICARE Young Adult or TRICARE dental options while this website is unavailable.
- <u>Beginning December 1</u>, DoD will "freeze" enrollment files as they will be transferred to the new TRICARE contractors and revise the plan options (Standard to Select) in the DEERS system.
- Beneficiaries can still send enrollment forms to the contractors and they will be processed in DEERS when the file transfer is complete. This will take 3 weeks.
- Regional contractors will accept enrollment applications through other channels, for example by phone and mail. The contractors will be able to process these enrollments after the freeze is complete.
- This will not affect any care you receive during the enrollment freeze. Remember to keep any and all receipts for purchased care.
- Remember, keep your DEERS information up to date as beneficiaries must be registered in DEERS to enroll in TRICARE Prime or a Prime option online, by phone or by mail.

What is the significance of these MOAA Level of Excellence awards?

Each year, state councils and local chapters may submit formal requests to MOAA to be recognized for their work and achievements. MOAA reviews the applications and evidence and may award one of two Levels of Excellence to the councils and chapters that have applied:

- 1. FIVE-STAR AWARD goes to "the very, very best councils or chapters."
- 2. FOUR-STAR AWARD is awarded to above-average councils or chapters.

MOAA has made revisions for the 2017 Level of Excellence (LOE) awards, which are designed "to encourage interest and increase the number of chapters eligible to compete for the LOE award." For the 2017 awards:

- Scoring will be aligned with traceable information from the MOAA database.
- Adjustments to achievable criteria will be made according to the percentage of chapter membership versus national membership.
- Criteria remain the same; however, the format is slightly different. The focus remains highlighting council and chapter legislative/grassroots advocacy, community engagement, and recruiting and retention.

The 2017 LOE submission deadline is May 1, 2018. The LOE award ceremony will be held in conjunction with MOAA's annual meeting, Oct. 30–Nov. 2, 2018, in Phoenix.
