# **VOTING ON CHAPTER LEADERS**

Our Chapter has five titled leadership positions, known collectively as Chapter Officers, and eight members comprising the Chapter's Board of Directors, one of whom is the Immediate Past President. Incumbents serve a two-year term starting at the beginning of an odd-numbered year. At the end of the second year, a nominating committee seeks out volunteers for these positions. Nominees are confirmed by the general membership present at the annual business meeting in December. At this year's meeting on December 9, we will be voting to confirm nominees for the 2019/2020 term. Prior to the vote, we will open the floor to allow members to make additional nominations.

#### **CHAPTER OFFICERS**

Chris Costigan, CDR USN Ret., presently the 1<sup>st</sup> Vice President, has volunteered to replace Skip as the President. The President presides at general membership and Board meetings, represents the Chapter at State and National events, and provides overall direction for the Chapter. Chris will also continue duties on the Program committee. We will be voting to confirm Chris and replace him as 1st Vice President. We will also be confirming the 2nd Vice President, currently Manny Biondi, MAJ USA Ret., (Continued on page 4.)

Secretary, currently Ralph Folger, LCDR USNR Ret., who is also our 5-star award winning Webmaster. We will also be filling the vitally important position of Treasurer, currently vacant.

#### **BOARD OF DIRECTORS**

The Board, together with the Officers, forms a deliberative body that makes decisions by majority vote on Chapter policies and operational matters. These include decisions on spending, revenue, such as dues, and program policies and events. A diversity of experience and perspectives helps the Board make sound decisions. Most of the Officers and Board members head or serve on the various committees that coordinate Chapter activities. Skip Bebernitz, MAJ USA Ret., will rejoin the Board as Immediate Past-President. All current members might be returning, but we might some new volunteers.

#### **COMMITTEES**

Past issues of this newsletter have described in detail the functions of the various committees; no need to repeat that information here, except to remind everyone that the committees, often only one person, plan and accomplish the specific tasks needed to run Chapter operations and advance the MOAA agenda. One need not be an elected official to serve on or head up a committee: Any Chapter member or auxiliary may participate. Committee heads are automatically members of the Board.

# MOAA GOALS, CALL TO ACTION

MOAA is pressing the 115th Congress during their "lame duck" session to accomplish their legislative agenda. Congress must first achieve a spending agreement to fund the federal government after December 7. They are also working on a Coast Guard reauthorization package and holding hearings on delays of GI Bill payments to students. If Congress fails to act on any of the defense bills before adjournment, MOAA will be "back to square one in January," to get legislation reintroduced and cosponsors to sign on. MOAA goals for the final session include these stand-alone bills:

- Expand presumptive exposure to Agent Orange of Blue Water Navy veterans who served in the vicinity of the Republic of Vietnam (H.R. 299 and S. 422). (Senator Gillibrand is the original sponsor of S. 422; Senator Schumer and all three of our current Congressional representatives, Faso, Stefanik and Tonko are co-sponsors of these respective bills.)
- Eliminate the widows tax on military survivors (H.R. 846 and S. 339): will repeal the requirement to reduce survivor annuities under the Survivor Benefit Plan by veterans' dependency and indemnity compensation. (Senator Gillibrand is a co-sponsor of S. 339; all three of our current Congressional representatives, Faso, Stefanik and Tonko are co-sponsors of the House version)
- End financial penalties for disabled veterans by allowing full concurrent receipt (H.R. 333 and S. 61): will permit retired members of the Armed Forces who have a service-connected disability rated less than 50% to receive concurrent payment of both retired pay *and* veterans' disability compensation, and to extend eligibility for concurrent receipt to chapter 61 disability retirees with less than 20 years of service.
