- NEW YORK STATE COUNCIL OF CHAPTERS 48th ANNUAL CONVENTION. Given our State Council's determination to maintain our *unbroken* string of annual conventions and given the uncertainty of reopening from the "Pause", the Council made a tentative plan for "an abbreviated program." MOAA NEWS

PANDEMIC NEWS. Twenty Veterans Administration (VA) medical facilities have reopened for **non**-COVID services, and among them is the **Syracuse VAMC** here in NY. Also, if you have been impacted by the corona virus pandemic or the response, MOAA wants you to share your story to enable MOAA understand better the needs of the uniformed services community. OUR FUTURE DINNER MEETINGS

We have two more Chapter luncheons scheduled for 2020: Oct 4 and Dec 13. But we do not yet have a venue for either. As Chapter members, you have a say in Chapter business. If you know of places that you think would be a great (not just adequate) locale for our meetings, please tell one of our Officers or Board members. The venues <u>must</u> ...

- Be centrally located in the Capital Region: roughly southern Saratoga, eastern Schenectady, central-eastern Albany, or western Rensselaer counties.
- Accommodate up to 40 people comfortably and apart from the public or other parties;
- Accept reservations (so we don't get bumped);
- Have ample parking and be accessible to older and disabled persons;
- Be clean;
- Consistently serve delicious food, with options for beef, chicken, seafood, and vegetarian dishes;
- Charge a reasonable price, preferably around \$30 per person including gratuities;
- Have friendly and responsive service;
- Have flexibility for accommodating lastminute changes.

Other considerations:

- Access to bar and/or hot beverages
- Attractive ambience
- A la carte pay-as-you-go option in lieu of set meals

- TRICARE NEWS. Effective May 12, changes to *telehealth* coverage are allowing more beneficiaries to access health care services through the end of the COVID-19 national emergency. The changes are:
 - 1. TRICARE will cover audio-only telehealth visits, consistent with Medicare's coverage expansion during COVID-19. This allows beneficiaries to consult providers who typically don't offer telehealth services and expands access for those beneficiaries who don't have video capability or broadband internet service.
 - 2. TRICARE has eliminated out-of-pocket costs for covered telehealth services. This copay/cost sharing waiver applies to all covered in-network telehealth services, not just services related to COVID-19. If you have any questions about covered telehealth services, please consult your managed care support contractor. It will take some time to update claims processing, so you may have to pay a copay/cost share up front and submit for reimbursement.
 - 3. TRICARE has expanded the number of providers able to offer telehealth services by allowing reimbursement for interstate care as long as the care is permitted by federal or state licensing laws.
- <u>VIRTUAL STORMING THE HILL</u>. Representatives Bill Posey (R-Fla.) and Kathy Castor (D-Fla.) circulated a congressional letter urging House Armed Services Committee (HASC) Chairman Rep. Adam Smith (D-Wash.) and Ranking Member Mac Thornberry (R-Texas) to ensure the FY 2021 National Defense Authorization Act (NDAA) includes language to **stop planned cuts to military medical capacity**. *Their letter clearly articulates the MOAA position* that the COVID-19 pandemic demands a reassessment of the medical readiness requirements, updated with lessons learned from our nation's response to the current health emergency. (The deadline for signatures was May 21, *so stay tuned*.)

BOOK REVIEWS

SARATOGA: A Military History of The Decisive Campaign of the American Revolution

Author: John F. Luzader, PhD in History and World War II Army Ranger

Original published in 2008 and republished in 2014, <u>Saratoga</u> is an exceptionally well written book on what many have called the turning point of The American Revolution, which Dr. Luzader expertly justifies. His obvious love of history and his employment as a Historian for the National Park Service, stationed initially at Saratoga, enabled him to research and write a fine and detailed narrative.

This 495 page book starts slowly as the author sets the stage with details on how "[t]he war from the side of the Canada" was devised, from General Washington's retreat across New Jersey in 1776 to General Burgoyne's convincing the King of England to place him in command of a 7,000 man army in Canada. The operation was to be in two phases: move south and capture Albany by the end of Summer 1777 then move east the following Spring and recapture New England, cutting off the New England rebels from those in Virginia.

Dr. Luzader goes into detail on Burgoyne's Army. He also goes into finite details about the acrimonious relationships between General Horatio Gates, General Benedict Arnold, and General Philip Schuyler and the backbiting that was common during the Revolution among many of those in Congress

and those serving under arms. He covers Burgoyne's movement south out of Canada, British operations at Ft. Ticonderoga, Crown Point, and Ft. George, as well as the battles at Ft. Stanwix and Bennington, the two battles at Saratoga, and General Burgoyne's attempted retreat and eventual surrender.

Dr. Luzader's decision to quote many original letters from the officers of each side's army made reading this book a challenge. The original thoughts and different perspectives from the men (and one woman) who were at Saratoga 243 years ago were interesting. However, the English language has changed a bit over 243 years, believe it or not, and reading old diary entries was tiresome. Overall, **I highly recommend this book**, especially to anyone who loves history and wants to know more about this pivotal battle. This book is perfect for any history buff's personal library.

CHURCH OF SPIES: The Pope's Secret War Against Hitler



My oldest son gave me this book for Christmas; the fourth book I've been able to read this year, thanks to the "Pause." And, it is a thriller. Before becoming Pope Pius XII on March 2, 1939, Eugenio Pacelli had been Papal Nuncio in Munich (1917), Papal Nuncio in Berlin (1920-29), and Vatican Secretary of State (1930). He had strong ties to Germany and many friends there. Pacelli extended all the usual diplomatic courtesies to Chancellor Hitler, although he was openly critical of the Fuehrer and the Nazi Party. But, as Pope, he



ceased his criticism after the bullets started flying and remained silent until the end of the war. Allied leaders were appalled that he did not speak out to condemn Hitler and Germany as news of atrocities against the Jews leaked out. The Pope's background and his silence led some historians to conclude that he was "Hitler's Pope". Yet, several Jewish leaders praised and thanked him after the war for his efforts and those of the Vatican to save many Jews. So, what in God's name (literally) was going on? Author Riebling did some serious exhaustive research to find out.

The list of the author's sources is 28 pages long (no breaks). Endnotes in small print span 72 pages! Nearly every paragraph in the 250 page story is annotated, drawn from one or more sources. Riebling exposes the actions of a hidden and largely unknown "theater of operations" of the Second World War in Europe. I am not an expert on the war, but I have solid knowledge of its major aspects. Yet, never in my life had I heard or read anything about any of this. It is quite a revelation, and much of it so farfetched to be unbelievable if it weren't confirmed by sources. Its telling is far from dull or pedantic. It is a compelling tale full of suspense. The narrative occasionally jumps back in time to bring parallel storylines together at crucial points. Otherwise, it flows well and is easy to read. I loved the plot twists and many surprises. The actors themselves, minor as well as major, were fascinating. The reader encounters despicable villains and honorable heroes, the highly competent and the unimpressive, and mostly regular people with their flaws and virtues. Clearly the author's favorite, and mine as well, is "Joey Ox." So, what was this "secret war" and how did it come about? How did it turn out, and what overall effect did it have on the war, if any? How was the Pope involved? What was Hitler's involvement? Well, I'm not telling you, because that would spoil the surprises that make this book so exciting to read. See for yourselves.
