# 2015 – TIME FOR ACTION



It is THAT time of year again. MOAA is gearing up to storm Capitol Hill in April to persuade key members of the new Congress to preserve the hard-earned benefits that compensate military personnel, both serving and retired, for their (our) many sacrifices. According to the NY Council of Chapters MOAA

Legislative Affairs Primer, "2015 will be an important year for attacks on all our benefits." The Military Compensation and Retirement Modernization Commission (MCRMC) includes recommendations that could negatively impact military personnel, and force readiness.

NY Council of Chapters President, Ben Margolius, and First Vice President, Peggy Phillips, are planning to meet with New York legislators including both NY senators, on April 25. Currently, they also plan to call on **Congressman Chris Gibson**, COL USA RET, 19<sup>th</sup> District, and **Congresswoman Elise Stefanik**, 21<sup>st</sup> District, who represent the southern and northern parts of our Chapter's region.

While it is true that a relative handful of MOAA's many members actually storm the Hill, ALL members are encouraged to take initiatives to support the effort. Ben and Peggy encourage MOAA Chapter members to stay informed about legislation that affects our benefits. The best way to do that is to subscribe to the MOAA Legislative Affairs weekly update on the MOAA web site, <a href="http://www.moaa.org/legislative/">http://www.moaa.org/legislative/</a>. MOAA leadership prioritizes the main issues for us in their MOAA's top issues page at <a href="http://www.moaa.org/topissues/">http://www.moaa.org/topissues/</a>.

Our Council of Chapters leaders are also encouraging each Chapters to "visit their New York State legislators to communicate MOAA issues," especially any representatives that the storming teams will NOT be meeting. For our Chapter, that would be Congressman Paul Tonko. The Council would like us to emphasize the three main issues the NYS storming teams will discuss with the NY senators and representatives. The MOAA goals on these issues are to:

- Sustain currently serving pay and benefits for FY 2016. The FY 2016 budget proposes capping pay below private sector pay growth for a 3<sup>rd</sup> straight year, possibly four more, reducing Basic Allowance for Housing by up to 5%, and reducing commissary savings for uniformed service families by 66%.
- Reject disproportional TRICARE fee hikes and plan changes, such as combining TRICARE healthcare plans; increasing fees & establishing a means-tested enrollment fee for TRICARE for Life; re-labeling the TRICARE Prime enrollment fee as a "participation" fee for working age retirees with no guaranteed access to care and with no evidence of a planned or managed network of available providers; forcing working age retirees to pay to be seen at military treatment facilities; and increasing pharmacy copays beyond the median of civilian plans.
- End the harmful effects of sequestration by supporting a bipartisan debt reduction package that avoids disproportional penalties on servicemembers and their families.

<u>GUEST SPEAKER</u>: Commander Donald McKnight, New York State Naval Militia

BIO: Commander Don McKnight is a native of Castleton on Hudson, and a graduate of SUNY at Oswego, St. Francis College, Loretto, PA, and the US Naval War College, Newport, RI. He was commissioned an Ensign, United States Navy in March 1983, and served five tours at sea as a

surface warfare officer [USS CONNOLE (FF 1056), USS HERMITAGE (LSD 34), USS McKEE (AS 41), USS TRUETT (FFT 1095), and USS JOHN C STENNIS (CVN 74)].



Commander McKnight's Navy shore assignments included the Navy Recruiting District Cleveland Ohio, and Naval Coastal Warfare Group TWO, Williamsburg, VA, and command of the Navy Reserve Centers at Ebensburg, PA, Albany, and Glens Falls, NY.

Upon retiring from the U.S. Navy in November 2005, he affiliated with the New York Naval Militia. He served as Assistant Officer-in-Charge and subsequently Officer-in-Charge of Region TWO. He is currently the Commander, New York State Military Emergency Boat Service. His military decorations include the Meritorious Service Medal, the Naval and Marine Corps Commendation Medal (five awards), the Naval and Marine Corps Achievement Medal (two awards), in addition to other campaign, unit and service awards.

#### New York Naval Militia Military Emergency Boat Service (MEBS)

New York State ranks 8th out of the 50 states in water area, with well over 9,000 miles of shoreline, and a 330 mile international water border with Canada. In 2001, NYS identified a need for a boat service to support homeland security efforts, particularly at the Indian Point Energy Center on the Hudson River, in Buchanan. This effort created the New York State Military Emergency Boat Service (MEBS) with its fleet of allaluminum, high speed boats patrol boats. These boats operate in waters throughout the state, including the Atlantic Ocean, Lakes Champlain, Ontario, and Erie, the Hudson and Mohawk Rivers, and throughout the state's canal system.

Some of the MEBS missions and operations include: port security, support of law enforcement, surveillance, evacuations, maritime transport, critical infrastructure protection, joint maritime operations, and vessel escort (force protection). 
