
# **CHAPTER LEGISLATIVE AFFAIRS**

Our Chapter's **Legislative Affairs Committee** (Pat Piccirilli, Chris Costigan, Dana Berntson, and Skip Bebernitz) really has been busy following up with our Congressional representatives after MOAA's annual "Storming the Hill". Our primary objective is to convince our members of Congress to protect the pay and benefits of all who served in our nation's armed forces. The specific objectives of each visit are:

- To continue a relationship with the member of Congress and the member's local staff;
- Review the three major issues on MOAA's fact sheets eliminating sequestration, eliminating the "Widows Tax", and maintaining equitable Tricare fees;
- Discuss the possibility of cosponsoring a bill and reviewing associated issues.

Here are summaries from reports of two visits our Chapter made recently:

- 1. VISIT WITH CONGRESSMAN **JOHN FASO**, 19<sup>th</sup> DISTRICT, 24 APRIL 2017.
  - a. <u>Executive Summary</u>: This was the first meeting with freshman Congressman John Faso. All objectives were achieved. Four chapter members presented folders with the MOAA fact sheets and associated information, and discussed MOAA's three major issues, explaining the reasons behind each issue. The Congressman said he will give serious consideration to co-sponsoring the house bill dealing with eliminating the "Widows Tax". The Chapter delegates informed him of their intent to return sometime in August as a follow up to this meeting.
  - b. <u>Discussion and Comments</u>: Congressman Faso listened intently and asked a number of questions to help him understand the issues. He agreed to review the issues identified by MOAA in the folders given him, and possibly co-sponsor the bill to eliminate the "Widows Tax". He might have been visited by a MOAA rep during



"Storming the Hill", but the Chapter's visit made him more aware of the number of chapters in the state and in his district. We may need to educate the Congressman on the total MOAA picture, including the alliances MOAA has with other mililtary advocacy organizations.

#### 2. VISIT WITH CONGRESSMAN PAUL TONKO, 20th DISTRICT, 9 MAY 2017.

- a. <u>Executive Summary</u>: This was the Chapter's third visit in three years to Congressman Tonko's office. All objectives were achieved. Chapter President "Skip" Bebernitz and Pat Piccirilli met with the Congressman, his District Director (Ryan Horstmyer), and an intern. The Chapter reps handed out folders with MOAA fact sheets and associated information, and discussed MOAA's three major issues, explaining the reasons behind each issue. They also pushed the concept of co-sponsoring a bill.
- b. <u>Discussion and Comments</u>: Congressman Tonko and his staff all listened intently. He opposes Sequestration and voted against the measure in 2011. Although he did not see anyone from MOAA during "Storming the Hill", he's heard concerns about the "Widows' Tax", and knew that Representative Joe Wilson initiated a bill to eliminate it. (He did not seem aware of the issue last year.) Our delegates explained the unfairness of that offset, and also explained MOAA's opposition to disproportional TRICARE fee hikes: TRICARE fee increases should not exceed the COLA for retirees' pay. This led to a discussion about calculating COLA percentage. Congressman Tonko said he would review the issues identified by MOAA and sponsor or co-sponsor a bill after review by his Defense budget adviser. He seemed to agree with MOAA's positions, but more work is required on our part and our Legislative Affairs Committee anticipates visiting him again in August.



### **BE CAUTIOUS WITH COMPENSATION REFORM**

In a 2015 report, the Military Compensation and Modernization Commission noted modernization might benefit individual compensation programs, but "the overall structure of the current compensation system is fundamentally sound and does not require sweeping overhaul." The commission also recommended keeping the basic pay table in its current form and continuing the basic allowances for housing and subsistence (BAH and BAS).



We need legislators to reflect on the potential derailment of a system that is currently working. Altering regular military compensation could have significant impacts on recruitment and retention.

## Currently on Exhibit at the NEW YORK STATE MILITARY MUSEUM

**CIVIL WAR PAINTINGS NOW ON DISPLAY:** This exhibit highlights some of the finest Civil War artwork from the collection of the Military Museum on a rotating basis. The first installment includes works by Thure de Thulstrop, including Thulstrup's vivid paintings that were used to create a set of chromolithograph prints in 1886 that became the most popular and best-selling prints ever produced. The exhibit will later include James Walker's twelve-foot long painting of the Battle of Resaca that had been believed to be lost since 1959 but was recently discovered and restored.

## FIERY TRIAL AND SACRIFICE: New York and the First World War.

Fiery Trial and Sacrifice chronicles America's road to war and the contributions made by New York State's military forces such as the 27th Division—proudly known as "New York's Own;" the "Fighting 69th"—New York City's famed Irish regiment; the 77th Division - known as "The Melting Pot Division", and New York's first African-American regiment which achieved wide acclaim and later became known as the "Harlem Hellfighters." A recreated trench features display cases filled with firearms and bayonets, gas masks and grenades, trench art, personal items and medical instruments.
