Out Chapter supports Wreaths Across AmericaTM (WAA), a 501(c)(3) corporation whose mission is to **Remember, Honor, and Teach** Americans of all ages about the sacrifices made by those who served our nation in her Armed Forces. Every December, on a designated Saturday before Christmas, WAA coordinates the laying of wreaths on veterans' graves at Arlington National Cemetery and at veterans' cemeteries in all 50 states. This year's wreath laying event will be held nationwide onSaturday, **December 18**.



Locally, our Chapter is promoting wreath sponsorship for the *Gerald B. H. Solomon Saratoga National Cemetery*, 200 Duell Rd, Schuylerville, NY 12871. There are 14,100 veteran graves there, and, as of September 21, a total of 2,953 wreaths sponsored. *11,147 more wreaths are needed*!



We urge all Chapter members to get your families and friends to sponsor wreaths through our Chapter. You may sponsor one or more wreaths by mailing your payment along with <u>the form on</u> <u>page 3</u> of this newsletter to WAA at their Maine address, or, following the instructions on

page 4 of this newsletter, through the WAA website at https://www.wreathsacrossamerica.org/. The cost to sponsor a single wreath is \$15. Our Chapter's WAA group code is **NY0087P**. In return for our efforts, our Chapter gets a small percentage of the total dollar amount donated through our group. This revenue, in addition to annual dues, helps to keep our Chapter solvent and able to donate to other worthy local causes. **Currently, a memorial ceremony is planned at the cemetery on December 18 at 12:00 pm prior to laying wreaths.** *We encourage everyone to attend the ceremony and help place wreaths on gravesites, if you are able.* This is a very moving and uplifting community event, as those of us who have attended in the past can attest!



Wreaths Across AmericaTM - Guidance for Sponsoring Wreaths Online

- On the home page, under the red "SPONSOR WREATHS" button, find and click on the tiny heading labeled "or <u>Local</u> <u>Fundraising Group</u>". That opens a box titled "Wreath Sponsorship; Choose Your Local Fundraising Group"
- Click on the button for the number of wreaths you wish to sponsor. Then, in the box just above the red button labeled "Review of Sponsorships", click on the space to the right of the icon of two people labeled faintly "Select Group to Support."
- With your cursor in the space, type in our group code NY0087P. The entry "New York State Chapter MOAA (NY0087P) (18601)" will appear *below* the space.
- 4. Click on "New York State Chapter MOAA (NY0087P) (18601)" The location "Gerald B. Solomon National Cemetery, Schuylerville" will appear below, to confirm you have the correct fundraising organization. *Select the number of wreaths you wish to sponsor*, and click on the red "Review of Sponsorships" button to be able to complete the transaction.

Chapter News and other local items of interest

• **LEGISLATIVE AFFAIRS COMMITTEE REPORT**. (submitted by Pat Piccirilli)

The latest step in the **FY 2022 National Defense Authorization Act** (NDAA) process offers a clearer picture of what MOAA priorities will make the bill's final version, what fights will continue in upcoming sessions, and where MOAA needs your help in pressing legislators to include muchneeded reforms. Now that both the House Armed Services Committee (HASC) and the Senate Armed Services Committee (SASC) have passed their respective versions of the legislation, the bills will be voted on in each chamber. However, no dates have been released for when these votes will take place.

The coming weeks and months will be critical as key legislators work to pass this pivotal piece of legislation. Floor amendments and a conference to resolve differences between the House and Senate versions of the NDAA are the next steps for this bill in the legislative process. MOAA will continue to engage with Congress as the NDAA moves forward and will provide our members with important updates via **The MOAA Newsletter** and **MOAA.org**. Here is a list of what was dropped and what was retained in the current version of the NDAA.

What's In

- Pay raise of 2.7%
- Basic Needs Allowance which was a MOAA Advocacy Action item earlier this year
- Reserve Component pay parity
- Halt in the reduction of medical billets
- Arlington National Cemetery issue to require a joint report as to the next National Cemetery

NEVER STOP SERVING

- Parental leave and child care
- Military Justice reform
- Survivor Benefit Plan (SBP) open season to be established for certain beneficiaries
- Selective Service enrollment for women

What's Out, for Now

- **Concurrent Receipt**: The Major Richard Star Act, a piece of concurrent receipt legislation supported by more than half the Senate and nearly 120 House members, is a pending NDAA floor amendment. Sen. Jon Tester (D-Mont.) and Rep. Gus Bilirakis (R-Fla.) are expected to propose the Star Act as an amendment; contact your lawmakers and ask them to support this effort.
- **TRICARE Young Adult**: Legislation that would expand TRICARE eligibility to young adult dependents up to age 26 (military kids lose TRICARE coverage at age 21 or 23 if a full-time college student.) to bring TRICARE in line with commercial plans, another of MOAA's Advocacy in Action topics, did not make it into the SASC or HASC bills.
- <u>CHAPTER MEMBERSHIP DUES.</u> Annual Chapter dues are **\$30**. We are up to <u>33</u> members who have paid dues for 2021. (Last year, 40 members paid.) Remember that Our Chapter now offers *THREE* options to pay annual dues: (1) Include your payment as part of your luncheon reservation or pay at the door when you attend a luncheon; (2) Mail a check, *payable to NYS CDC MOAA*, either directly to Treasurer, Al Memole, at 8 Rose Lane, Rensselaer, NY 12144, or to our Chapter PO Box in Waterford; and *now* (3) Pay by credit or debit card online through the MOAA website

Book Review – THE THIRD REICH AT WAR

Author: Sir Richard J. Evans, © 2008, 765 Pages

This was the third book in Evans' Third Reich Trilogy, a series of books that historians the world over have nothing but praise for. This book covers the Third Reich between 1939-1945.

I chose this book due to the high praise and recommendations as a "must read book" for a pending trip to visit European Battlefields of WWII that was scheduled to take place in Sept 2020. I was interested in learning about German military operations from a German perspective; sadly that was not the case with this book. Any real operational details did not occur until page 403, and then again not until page 618, when the book focused on the last days of the war.

It took me 10 months to read this 765-page tome because of the grotesque details Evans writes about in regards to the Holocaust. As a student of history, focusing on American military history, I believed I knew most *everything* I thought I needed to know about WWII and the Holocaust.....I was

wrong! The voluminous research and level of detail in his book slowed me down to reading only a few pages at a time.

My school days are way behind me and today I read for, but this book was extremely difficult to read and was not at all enjoyable. However, if anyone is interested in learning *everything* about the Third Reich, then Richard Evans' Trilogy is truly a must-read.
