Guest Speaker: CAPT Frank J. "Tank" Michael, USN Ret., MOAA Program Director, Council and Chapter Affairs

Captain Michael had a 30-year career as an Navy aviator. He commanded the Helicopter Anti-Submarine Squadron Light 47 (HSL 47) where he led efforts following the 2004 Indonesian tsunami and Hurricane Katrina. He also commanded the USS Boxer (LHD 4) and participated in the 2011 Captain Phillips rescue operation in the Indian Ocean. Major staff assignments included the Joint Staff, CNO Fellow, Chief of Naval Operations Strategic Study Group, and Strategy Branch Chief on the Navy Staff.

After retiring from active duty in 2015, he served as senior vice president for Programs and Membership at the National Defense Industrial Association, and executive vice president at the United States Navy Memorial. CAPT Michael joined the MOAA Staff in 2021. As the Program Director for Council and Chapter Affairs, his primary responsibility is the support of MOAA's nationwide network of affiliates to influence legislation, serve their local communities, expand local and national membership, and raise awareness of the MOAA brand nationwide. HIGHLIGHTED CHARITY for this issue → GUARDIAN HOUSE

Every year as winter ends and spring begins, we appeal to our members to support the *Guardian House* for homeless female veterans and the *Vet House* for homeless male veterans. The **Veterans & Community Housing Coalition (VCHC)** of Saratoga County operates these homes and provides other services for needy veterans in Saratoga, Warren, Washington, Fulton, Montgomery, Schoharie and Schenectady Counties. Besides transitional housing, the VCHC provides of peer support programs, temporary financial assistance, help to obtain/maintain housing, and help to secure VA benefits, health care, employment, and other public aid. Their latest effort involves support for "*Foreverly House*", a

- **STRIDE WOUNDED WARRIORS SNOWFEST WELCOME CEREMONY.** This year’s ceremony on March 4 was greatly reduced in size and scope from previous years, but not reduced in spirit. The uncertainty surrounding the status of COVID restrictions in early February, when STRIDE had to make decisions, led them to choose the safest guarantee: hold the ceremony in the STRIDE center in West Sand Lake with its space limitations. Maximum attendance was set at 75 persons including local dignitaries. Because our Chapter contributed toward the Snowfest (\$400), we were considered VIPs. Unfortunately, only one of us was able to attend (I, your *new* President and Editor-for-life). STRIDE welcomed six new wounded warriors this year, two local and four from downstate. Since there was no printed program, we don’t have all their names to show here. But the ceremony was as heartwarming as ever. Cadets from LaSalle Institute in Troy provided the color guard. A young STRIDE participant sang the national anthem. **BG Barry Hartman, USA Ret.,** and **CSM Bob Van Pelt, USA Ret.,** were there to help present citations to the warriors. Special guest speaker, **BG Denise Donnell,** Commander, 105th Airlift Wing, NY Air National Guard gave an excellent inspirational talk to prepare the participants mentally for a challenging weekend of snow sports at Jiminy Peak, Hancock, MA.

- OUR LAST LUNCHEON MEETING, FEBRUARY 13.** Only *fifteen* members attended this meeting at Martel's Restaurant at the Capital Hills Golf Course in Albany. Illness and injury prevented a couple others from joining us. (*Please, let's resolve to have better attendance at future luncheon meetings.*) Those who attended had a wonderful time. The venue was small and somewhat spartan, but nice; the food was fairly good (one report of dry salmon). Plus, the Costigans brought a yummy cake for dessert. The best part was meeting and listening to our two guest speakers, Cadet seniors **Avero "AJ" Howard** (*at left*) and **Jabari Laws** (*at right*), from the United States Military Academy (USMA) at West Point.



Both cadets played on the West Point Black Knights Football team: AJ as running back and Jabari as quarterback. And both will be commissioned as cavalry officers in the Armor Branch at the end of this school year. Together they gave a lively presentation on life at the



Academy, complete with slides. They discussed their personal experiences year by year, explaining how they met the challenges, such as coping with injuries, COVID, and related restrictions, and how the USMA program helped them grow and improve in knowledge, ability, and confidence. AJ Howard, although modest about himself, sang the praises of his classmate, teammate, and friend, Jabari, who rebounded after being seriously injured twice during his four years at West Point to serve as a back-up QB. His perseverance paid off in their last game on December 22 in the Armed Forces Bowl against Missouri. Jabari was sent in late and completed two passes in four attempts for a gain of 24 yards *that set up the game-winning field goal!* It was such a pleasure to meet these two fine young men who will soon be commissioned officers leading soldiers. It gives us great hope for the future of our great nation and her Armed Forces.

We capped this exciting meeting off with the formal installation of newly elected Chapter Officers and Board Members for 2022-2023. (See the list of new Chapter leaders on page 10 of this newsletter.) Skip Bebernitz, in his role as the President of the NYS Council of Chapters, presented the MOAA award to Chris Costigan for his outstanding contributions to MOAA and our Chapter.

- **LEGISLATIVE AFFAIRS COMMITTEE REPORT – March 2, 2022.** (submitted by Pat Piccirilli)

The latest news from MOAA concerns the push for *legislation to cover veterans suffering from toxic substances*. The **Honoring Our PACT Act** offers health care for veterans exposed to toxic substances, seeks to reform the presumptive illness process, and adds presumptive illnesses for multiple generations of veterans. Along with adding many presumptive illnesses for burn pits, the bill would make several significant improvements to benefit eligibility, to include:

- Caring for long-overlooked veterans by recognizing radiation exposures for veterans who served in the Enewetak Atoll and Palomares, Spain, and Agent Orange exposure for those who served in Thailand, Laos, and Cambodia.
- Adding hypertension as an Agent Orange presumptive illness.
- Eliminating the sunset for benefits related to Gulf War illnesses.

The House's (H.R. 3967) move comes in the wake of *the Senate passing a standalone health care bill that would extend VA health care for combat-deployed veterans from five to 10 years*. The Senate's vote was part of a planned, three-phase approach that Senate Committee on Veterans' Affairs Chairman Jon Tester (D-Mont.) negotiated with Sen. Jerry Moran (R-Kan.), the committee's ranking member. While MOAA supports the Senate health care bill, it is not nearly as robust as the House version. Those who deployed earlier in the Global War on Terror and separated prior to 2011 would not have a clear path to health care under the Senate bill.

Now is the time for our chapter members and other veteran

groups and advocates standing together and supporting the strongest possible package. Please take the time to contact your Congressional representative by clicking this link:

MOAA'S ANNUAL ADVOCACY IN ACTION IS TAKING PLACE THROUGHOUT THE MONTH OF APRIL.

50TH ANNIVERSARY OF THE VIETNAM WAR COMMEMORATION CEREMONY

The *Capital District of New York Chapter of the Association of the United States Army (AUSA)*, in conjunction with the *Friends of the New York State Military Museum*, will conduct a 50th Anniversary of the Vietnam War Commemoration ceremony on **Tuesday, March 29, 2022, starting at 7 pm at the Saratoga-Wilton Elks Lodge (1 Elks Lane, Saratoga Springs, NY)**. The event will recognize and honor the service of Vietnam War Era Veterans who served in the military during the period of November 1, 1955 thru May 15, 1975 and have time on active duty even if only for training. All branches of the service - Army, Navy, Air Force, Marines and Coast Guard, qualify. The event is free and open to the public, but Veterans who register in advance will receive a Vietnam War era lapel pin. The lapel pin is issued by the United States Department of Defense as part of its 50th Anniversary of the Vietnam War Commemoration, a multi-year program to thank and honor Vietnam Era Veterans and their families for their service and sacrifice. This "lasting memento of the Nation's thanks" is now proudly worn by more than 2 million previously unheralded patriots. A Surviving Spouse pin will also be issued to the spouse of a deceased Veteran who served on active duty in the United States Armed Forces at any time during the period noted above regardless of location. *Veterans and Surviving Spouses may register for the event by contacting CSM(R) Bob Van Pelt at 518-210-2868 or email at bvpcsm@aol.com. Registration must be completed no later than March 25, 2022.* Please provide your name, dates of service and name of spouse/family/guest you will bring. Each individual Vietnam War Era Veteran will be recognized and presented with the lapel pin and have an opportunity to say a few words. Refreshments will be served. Prior pin awardees are welcome to attend and make remarks. Everyone attending must register. All registering must be prepared to show proof of vaccination prior to entry.

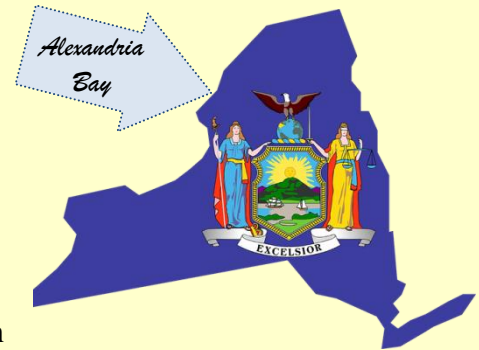

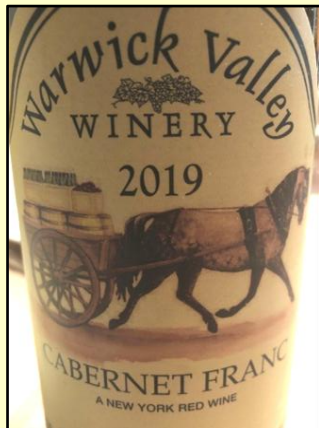
- Provide Superior Experience for Attendees.

WINE REVIEW

(Submitted by Al Memole) The last of the three wines in the gift basket that I won from the raffle at the NYS Council of Chapters Convention last October was a 2019 vintage **Warwick Valley Cabernet Franc**. The wines were from Viscount Wine & Liquors of Wappingers Falls donated for the raffle by *LTC Jack Carlson, President of the Mid-Hudson Chapter*. Unlike the other two wines from the gift basket that I reviewed in the last issue, this one is a **red** wine made 100% from Finger Lakes Cabernet Franc grapes and produced and bottled in Watkins Glen, NY. The back label says it was fermented in stainless steel containers then aged for six months in barrels, and has a fruity taste with aromas of black cherry and black currant that pairs well with “red meats, wild game, or cheese.” I tasted it first prior to a meal and found it to be light (as opposed to full) and tangy; not a “wow” but not unpleasant. It smelled and tasted a bit fruity but I couldn’t distinguish the type of fruit or fruits. That’s probably because I don’t remember how black cherry or black currant smell or taste. Next I drank a glass with a meal of lasagna (red sauce, pasta, ground beef and parmesan cheese), tossed salad, and a dinner roll. The wine went well but was eclipsed by the main dish with its tomato-based sauce. I finished the bottle over a two week period with



three other meals – two Italian main dishes and one chicken. The wine was good, but it didn’t stand out, at least, not to my taste. To be fair, I didn’t try it with any red meat other than ground beef in tomato sauce. Nor did I try it with cheese only, or wild game. (Ah, if only I had bagged one of those deer eating the seeds from our bird feeders!) Perhaps I should get another bottle and continue tasting.
