#### **Chapter News**

#### • LEGISLATIVE AFFAIRS COMMITTEE REPORT

(Submitted by Pat Piccirilli, Legislative Affairs Committee)

It's that time of the year and so here are the three issue areas comprising this year's **Advocacy in Action** (AiA) campaign as approved by MOAA's board of directors on Jan. 19<sup>th</sup>.

1. The Major Richard Star Act: The Major Richard Star Act (H.R. 1282/S. 344) would end an unjust offset for combat-injured veterans who lose a dollar of service-earned retirement pay for every dollar of VA disability compensation. The bill has a supermajority of bipartisan support – more than 325 House co-sponsors and more than 70 in the Senate – thanks in part to past grassroots efforts from MOAA and partners in The Military Coalition. Some points to bring up to your legislator include the fact that retirement pay is earned for years of service and is provided by DOD whereas disability compensation is for a lifelong injury and is provided by the VA-two different payments for two different reasons from two different agencies. Docking retirement pay of 27,000 combat injured service members to pay for other programs is an injustice. Also roughly half of the veterans are covered by Combat Related Special Compensation (CRSC) which was developed to recover some, or all of their retirement. However, it is estimated that most of these service members would benefit more from receiving their full retirement pay concurrent with the VA disability benefit. This legislation would provide the option to retain CRSC or service earned retirement pay.

The plan at this point is to keep up this momentum and secure the bill's inclusion in the FY 2025 National Defense Authorization Act (NDAA). It's time for lawmakers to push this long-delayed step toward concurrent receipt for all past the finish line.

2. The B.A.H. Restoration Act: The BAH Restoration Act (H.R. 2537/S. 1823) reverses DoD policy capping the Basic Allowance for Housing (BAH) at 95% of local rental and utilities costs – a policy that's placing a financial burden on servicemembers and families in the middle of a nationwide rental shortage and ongoing recruiting challenges. Restoring this benefit – it was cut by Congress incrementally beginning in 2015 – would make a difference in the quality of life for all who serve, but especially among junior enlisted members and their families, who rely on this allowance as a large percentage of their compensation. Language requiring an incremental increase reached the late stages of the FY 2024 NDAA process but ultimately was not included in the final bill. We must send a message to lawmakers that "close isn't good enough – servicemembers deserve a full housing allowance", and more progress must be made this legislative session.

3. <u>TRICARE For Life</u>: Protecting TRICARE For Life (TFL) remains a key issue for all MOAA members – those already covered by TFL and Medicare, along with those who'll use the benefit when they turn 65. MOAA remains concerned about a <u>Congressional Budget Office (CBO) report</u> suggesting two measures which would severely weaken the benefit – enrollment fees topping \$1,100 per family, and cost-sharing requirements including an \$850 deductible and up to \$4,675 in potential yearly medical bills.

Legislators seeking solutions to budget gaps must hear a clear message: Maintaining TFL is not just a national obligation to those who spent decades in uniform, it's also critical to ensuring key influencers in the recruiting process aren't discouraged from recommending uniformed service to future generations. While TFL fees or cost shares aren't part of any current legislation, we must counter CBO's misguided options with our grassroots advocacy efforts. The next CBO release is slated for December of this year, following the elections; MOAA will update our members as soon as we get the report.

As a side note, *Skip Bebernitz* and I are honored to be on the team representing the state of New York during this upcoming AiA event. .We are joined by *Matt Sprenger*, Mid-Hudson Chapter president.

While the three issues above represent National MOAA's AiA efforts there are still many issues that we need to bring to our legislators' attention. Some of these are listed below:

- o Arlington Cemetery expansion "Expanding America's National Cemetery Act" H.R.1413
- o Dental Care for reservists "Dental Care for our Troops Act" H.R. 4220/S. 2046
- Allow retiring service members to apply for DoD civilian positions without waiting six months post-retirement "Retain Skilled Veterans Act" H.R. 939/S. 334
- Remove service earned disability benefits from HUD's income calculations. The "Home for the Brave Act" H.R. 6179. This act will also remove Dependency and Indemnity Compensation (DIC) from HUD's income calculations.
- Reduce the burden on transitioning active-duty military spouses employed by federal agencies. "Resilient Employment and Authorization Determination to Increase the National Employment of Serving Spouses (READINESS)" H.R. 6462



We also got to chat with Jake and his wife, Navy *Commander Dave Latta*, RPI's NROTC Commander, and his wife, *LTC Luis Mejia-Roman*, head of Army ROTC, and one of his instructors, *Major Effe Oghre* (I might have spelled MAJ Oghre's first name incorrectly).

As things were wrapping up (for some of us), a young cadet rushed up to greet me. *Jesus Castillo* recognized my name when he heard it. I had the honor of presenting the MOAA JROTC award to him in 2021 when he was a junior at Albany High School (*Senior Military Advisor is our own MAJ Dave Erickson*). At that same ceremony, he assumed command of Albany High's Sgt. Henry Johnson Battalion – the highest position in the JROTC program. We spoke again at the following year's award ceremony when, as a graduating senior, he relinquished command. He told me then that his plan was to become a military pilot and eventually fly for a commercial airline. Now at Hudson Valley Community College and cross-enrolled at RPI for ROTC, he is still unwaveringly pursuing those same goals. I have no doubt that he will succeed. It illustrates that sometimes a gesture that seems relatively minor, like awarding a medal, can make an impression or have an impact that we cannot perceive at the time.
