



HAROLD JAMES BROCKMAN, LCDR US Navy (Retired), passed away on May 11, 2024, at age 93. Born in Nebraska, Harry earned degrees in architecture and German literature. He served on active duty as a Seabee in the U.S. Navy with duty in Okinawa, Japan, from 1960 to 1964. He continued his military service in the Naval Reserves into the early 1980s. In his profession as an architect, he designed buildings all over the US and in foreign countries, including Brazil, Saudi Arabia, and Nicaragua. In June 2022, Harry took a Patriot Flight to Washington, D.C., accompanied by his loving daughter, Amy. ## **Legislative Affairs Committee Report**

(Submitted by Pat Piccirilli, Legislative Affairs Committee)

Here's a look at some of the key issues MOAA will champion for inclusion in the FY 2025 NDAA, along with links to more information and ways you can make your voice heard via our <u>Legislative</u> Action Center.

- Enact the Fiscal Year (FY) 2025 Defense, Military Construction and Veterans Affairs appropriations bills, as well as the other appropriations bills, and the National Defense Authorization Act (NDAA) by October 1, 2024. This is critical to national security, which requires a whole-of-government approach. Without consistently on-time authorizations and appropriations, Congress has lapsed into an overreliance on continuing resolutions, causing uncertainty and waste throughout the federal government and placing an unfair burden on the all-volunteer force. MOAA, the Military Coalition (TMC), and other stakeholder groups already have engaged with lawmakers to advocate for key priorities they would like to see addressed in the FY 2025 NDAA. This must-pass legislation offers the largest annual platform for MOAA's work to support and protect service-earned benefits, while ensuring the continued strength of the all-volunteer force.
- Uniformed Services Pay Raise: The Employee Cost Index (ECI) rose 4.5% in the third quarter of FY 2023; by statute, that figure should set the pay raise for servicemembers beginning in January 2025.
- Basic Allowance for Housing (BAH): MOAA urges Congress to support the BAH Restoration Act (H.R. 2537/S. 1823) and include it as part of the FY 2025 NDAA so that BAH is restored to 100% of projected housing costs, up from the current 95%.
- Basic Needs Allowance (BNA) Calculation: Food insecurity among the ranks is a problem, especially for junior servicemembers and their families. DoD's budget request included a change in eligibility for the BNA, boosting the threshold from 150% to 200% of the federal poverty guidelines.
- TRICARE Network Adequacy Oversight: Reports of network erosion are increasing. MOAA
  recommends a Government Accountability Office (GAO) review of the next-generation
  TRICARE contracts to ensure they are structured to identify network adequacy issues and
  improve beneficiary access to care.
- Concurrent Receipt: MOAA continues its work to urge lawmakers to end the unjust offset faced by combat-injured veterans, tens of thousands of whom remain unable to receive their full DoD retirement pay and full VA disability compensation. MOAA is asking lawmakers to include the Major Richard Star Act (H.R. 1282/S. 344) in the base text of the FY 2025 NDAA.
- **Military Spouse Employment**: Military spouses continue to face a staggering unemployment rate over five times the national figure. Addressing decade-plus-long high unemployment among military spouses will take a multipronged approach, to include improved tracking of military spouse employment beyond the existing biannual survey.
- Servicemember Pay During a Government Shutdown: Often, there are measures in place to ensure members of the armed forces continue to receive pay even in the event of a lapse in government funding. However, these protections do not extend to the broader uniformed services

to include the Coast Guard and the commissioned corps of the U.S. Public Health Service and NOAA. Including the bipartisan Pay Our Coast Guard Parity Act (H.R. 2693) in the FY 2025 NDAA would be a significant step forward on this issue.

#### CONGRESSIONAL CALENDAR FOR THE REMAINDER OF 2024 - FYI

**Aug 1**: The last day both the House and Senate were expected to be in session before leaving for a five-week recess. MOAA will make additional resources available to members seeking to reach out to their lawmakers during this break, which many House and Senate members will use to connect with constituents.

**Sep 9**: Both the House and Senate return to work for three weeks. This period represents the last chance for Congress to pass a budget before the end of the fiscal year – a key duty of lawmakers, one that they've failed to accomplish (with rare exceptions) for several decades.

**Sep 27**: The end of the three-week working period. Both chambers will adjourn until after the election.

Sep 30: The end of the current federal fiscal year.

**Nov 5**: Election Day.

**Nov 12**: Both the House and Senate return for a "lame-duck" session. Despite the name, this session may prove critical to the advancement of the FY 2025 National Defense Authorization Act (NDAA), must-pass legislation which contains many key MOAA priorities. (During the lame-duck session after the 2022 midterm elections, that year's NDAA saw dozens of legislative actions eventually moving to the president's desk and becoming law before year's end.)

Nov 21: The last day both chambers are in session prior to the Thanksgiving holiday.

**Dec 2**: The Senate begins its three-week, year-end session; the House starts the following day.

Jan 3, 2025: Start of the 119th Congress.

MOAA is <u>NOT</u> an organization of officers concerned *only* about officers. We are an organization of officers dedicated to protecting the earned benefits and welfare of ALL RANKS in all of the uniformed services.

## **Our Last Luncheon Meeting – June 9th**

Despite predictions of rain, 17 members and guests enjoyed a beautiful sunny afternoon at the outdoor Pavilion of the Veterans of Lansingburgh facility along the Hudson River, across from Peebles Island



State Park and the Erie Canal lock in Waterford. Once again, the VoL served delicious summer cookout-style fare – hot dogs, hamburgers, corn on the cob, baked potatoes, tossed salad, grilled half-chickens, and watermelon. *Matt Sprenger*, COL USA Ret., who is the President of the Mid-Hudson Chapter, joined us to share camaraderie and hear our guest speaker, *COL Alain Fisher*, Commander, US Army Watervliet Arsenal.

COL Fisher talked about being "an Army brat" and recounted his Army experiences as a Quartermaster officer and logistician. His assignments prior to commanding the Arsenal took him to Hawaii, Virginia (multiple times), Korea, North Carolina, Italy, Georgia, and Kentucky. He also deployed to Afghanistan for OPERATION ENDURING FREEDOM three times (2006, 2007, and 2013). He spoke very passionately



about the Watervliet Arsenal and its vital role in US defense. The high level of quality control in production greatly impressed him, and he expressed optimism about future weapons systems. [On July 25, COL Jason W. Schultz assumed command of the Watervliet Arsenal, replacing COL Fisher.]






## **Chapter Trips & Outings**


June 12 – Tour of the Purple Heart Hall of Honor (PH HoH). Chapter members *Tony Ficara*, Vince Memole, and Al Memole joined MOAA members from the Mid-Hudson and Southern Tier Chapters for a tour of the PH HoH, hosted by our April 2023 guest speaker, *Peter Bedrossian*. The PH HoH is a unique *national* place of tribute to the PH and its holders, but is not a US Government site: It is actually part of the New York State Department Parks Recreation, and Historic Preservation. It is a national repository for official historical documents and artifacts as well as personal documents, stories, and artifacts dedicated solely to the Purple Heart medal, those who created the award, and, most importantly, those who received it – those wounded and those killed in action. The Hall is also a museum and an educational medium presenting the artifacts, the history, and the personal stories of the PH and its recipients. Although it's not a large area, it's packed with interactive displays that flow in a logical order. It starts with the creation of the award and follows its history. What makes the museum special is that it follows the personal stories of PH recipients through official documents, personal correspondence, photographs, and audio and video recorded testimony. Stories are grouped by war and conflict, but also by sequential steps in recipients' combat experiences. Experiences span the time from entrance into the armed services including personal motivations for joining, training, deployment and combat, wounds or death, emergency aid and evacuation from the combat zone, hospitalization and medical interventions, reception of the award, and, for those who survived, convalescence and adjustment to post-conflict life. There is also an authentically reconstructed Revolutionary War cantonment adjacent to the PH HoH. Its history and artifacts are displayed in the same building as the Hall of Honor.

#### NYS Assembly Bill A 9900 and NYS Senate Bill S8999 - Status

NO ACTION SINCE OUR LAST NEWSLETTER. Assembly Bill A9900 was referred to the Veterans Affairs Committee on April 26 and NY Senate Bill S8999 was referred to the Senate Finance Committee on May 16. <u>Background</u>: Money that New York State had collected from check offs on individual income taxes that were specifically meant to help veterans within New York has been sitting in the state treasury <u>and not a penny of it has been distributed yet to benefit veterans</u>. State legislators are attempting to address this odd and unjust retention of taxpayer funds through identical bills drafted in each house. The bills would direct "...that moneys in the veterans' home services fund shall be payable on vouchers certified by the commissioner of veterans' services; directs a report to be submitted by such commissioner; directs that moneys in the military family relief fund shall be payable on vouchers certified by the commissioner of veterans' services." Please contact your Assembly Representative and State Senator asking that they support the passage of this legislation.

# **BOOK REVIEW**

The Bedford Boys: One American Town's Ultimate D-Day Sacrifice

Author: Alex Kershaw Length: 240 pages

Kershaw has written many books about historical events and uses this book to tell the stories of the 22 boys from rural Bedford, Virginia; all of them assigned to the 116th Infantry Regt of the 29th Infantry

Division. Nineteen would be killed in the first 30 minutes when CO. A of 1st BN/ 116th INF Regt is part of the first wave to land on Omaha Beach on June  $6^{th}$  1944.

Kershaw does a fantastic job describing life in Bedford during the depression of the 1930s and how most of the boys joined the National Guard simply to earn extra money to feed their families. He introduces us to each "boy": what they looked like, how they did in school, their lives, their families, their homes, the things they did after high school graduation, their jobs, what they thought about after joining the local National Guard, and briefly what they did on "Drill Night" at the local armory for \$1 in pay every night they "drilled". He mentioned their "summer camp" training in the summer of 1939 and how different it would be the following year after FDR called up the entire National Guard for one year of training beginning in the late fall 1940. Some units would not see home again until late 1945. He described the training in the States and how things slowly got more and more serious the longer they were away, and then writes about the training that took place in England when they arrived in 1942. The "boys" had some fun on weekend passes, to include the 29th Division, including a few Bedford boys, winning the European Theater of Operations (ETO) World Series game in early May 1944.

Kershaw spends considerable time describing the landings on Omaha Beach and recounts in detail what occurred with the first wave to hit the beach. He recounts what each of the soldiers did or was assumed to have done in that first 30 minutes of what one can only imagine was pure hell, with chaos and total confusion added for good measure. Many of the survivors said they were told the Navy and the Air Corps would pulverize the beaches and the landings would be just like training. We now know how wrong they were. The book also covers the actions of the senior leaders who landed in the 3rd and 4th waves and how they got the "boys" moving and off the beach and over the sea wall. The final chapters of the book, the most gut wrenching to read, retell what occurred on "bloody Omaha". Kershaw describes the four-week wait for news, any news from anyone about what occurred on June 6<sup>th</sup>, how the little rural town and the families in Bedford reacted when the news finely started to trickle in via Western Union Telegraph, and what the town's telegraph operator and the locals she relied on did for days as the sad news began to arrive.

This is a fantastic book that starts out slow-paced in the beginning but picks up the action as it goes along. Always having been fascinated about The Second World War my entire life going all the way back to grade school (yes I should have become a history teacher), I knew why Bedford Virginia was selected as the location of the National D-Day Memorial and I highly recommend that everyone visit it (a 2.5-hour drive from Richmond). Reading about the lives of the "Boys from Bedford" who grew up there and went off to war is a story I will never forget.
