Legislative Affairs Committee Report

(Submitted by Pat Piccirilli, Legislative Affairs Committee)

Pay Raises, Pensions and the BAH. The December 30 edition of the MOAA newsletter published the latest updates regarding pay raises, pensions and the BAH:

Pay Raises: Military service members in the ranks of E-1 through E-4 will receive a 14.5% raise next year. President Joe Biden signed the 2025 pay raises into law Dec. 23rd. Most other service members will get a 4.5% pay bump. Some senior officers, including O-8s with 30 or more years of service, all O-9s and all O-10s, will receive smaller percentages because their pay can't, by law, exceed that of Level 2 of the Executive Schedule, according to an executive order published by the Office of Personnel Management.

The 4.5% raise will take effect at the beginning of 2025, while the extra 10% raise for junior enlisted troops will kick in at the start of April. With the 14.5% raise, junior troops will earn about \$3,000 to \$6,000 more per year, depending on rank. For example, E-1s will make \$27,828 per year, compared

to \$24,206 now, while E-4s with at least six years of experience will make \$44,107, compared to \$38,368 now.

The pending 4.5% raise doesn't quite match service members' 5.2% increase in 2024 or 4.6% in 2023, but it still tops the 2.7% and 3% raises in 2022 and 2021, respectively. While not as high as a House panel's initial 19.5% proposal for a junior enlisted raise next year, the compromise 14.5% raise marks a major win for younger troops who have struggled for years to afford basic necessities such as food.

Pensions (2025 Veterans Pension Rates): Meanwhile, the Department of Veterans Affairs released its 2025 Veterans Pension income limits. The new limits change veterans' individual rates. The actual amount paid depends on a veteran's income; the pension payment makes up the difference.

Veterans of wartime service who are 65 or older and on a limited income may qualify for a veteran's pension without being disabled. Wartime veterans may also qualify who have a limited income and can no longer work. For example, for a veteran with no dependents, the 2025 VA pension income limit (effective Dec. 1, 2024) is \$16,956. With a spouse or child, it's \$22,216.

Survivors Pension: Additionally, the VA has released its new rates for the Survivors Pension, also known as the "death pension," a tax-free benefit paid to eligible dependents of deceased wartime veterans. For those eligible, the VA pays the difference between your countable income and the yearly income limit that describes your situation.

BAH (Basic Allowance for Housing): Another important update for 2025 is the Basic Allowance for Housing, which will increase by 5.4% for the second year in a row. The Defense Department calculates BAH rates based on a uniformed service member's geographic duty location, pay grade and dependency status, along with housing costs in each local market. Each year, the department releases new BAH tables in mid-December for rates effective Jan. 1. There is also a special type of Basic Allowance for Housing known as BAH Transit, BAH Type II, BAH Non-Locality or BAH Reserve, depending on what branch you are in and your status.

NDAA Updates: At more than 1,800 pages, the FY 2025 National Defense Authorization Act (NDAA) will shape the service-earned benefits of those in uniform, and their families, well beyond the fiscal year. The bill, which cleared Congress last week and was signed into law by the President Dec. 23, includes dozens of provisions tracked by MOAA throughout the long lawmaking process with several more proposals that did not make the final cut.

MOAA Advocacy Focus for the New Congress. Here's a more complete breakdown of the legislative highlights, including areas where MOAA hopes to secure *future improvements via advocacy work with the incoming 119th Congress:*

Pay and Allowances

Highlights: MOAA outlined details of the junior enlisted pay hike and the 4.5% raise affecting nearly all other servicemembers, along with increased eligibility for the Basic Needs Allowance (BNA), shortly after the bill passed the Senate on Dec. 18. MOAA will continue its work to restore BAH to 100% of anticipated housing and utilities costs – provisions authorizing funds for such an increase did not make the final legislation.

Health Care

Highlights: The bill includes reforms designed to improve beneficiary access to health care, such as allowing tele-mental health providers to offer services across state lines; a waiver for the referral requirement for some types of care for servicemembers under TRICARE Prime; and the end of co-

pays for TRICARE contraception coverage. MOAA will advocate for a number of improvements left out of the NDAA late in the process, such as:

- A pilot program to treat pregnancy as a qualifying life event under TRICARE.
- Expanding coverage of hearing aids to children of retirees using TRICARE Select (a recent change covered children under TRICARE Prime).
- Creation of a TRICARE dental plan for Selected Reserve members.
- A report on the TRICARE retail pharmacy network, to ensure beneficiaries, especially those in rural areas, can access the care they need.

Spouse and Family Support

Highlights: A full breakdown of MOAA priorities in this bill touches on spouse employment improvements, upgrades to military housing, and improvements to military child care. MOAA sought expanded flexibility for military spouses who work for the federal government and face career challenges brought on by PCS moves – a provision that did not reach the final legislation. Other unfilled priorities included reports and studies on several programs, such as the Exceptional Family Member Program, DoD child care services, and home-based businesses on military installations.

Retirees, Survivors, and Veterans

Highlights: Several sections of the bill provide for the restoration of caisson services at Arlington National Cemetery, which have been suspended since May 2023.

Survivor Support: The NDAA provides an extension for minor dependents to file death gratuity claims. It also opens enrollment in DoD-run elementary and secondary schools to some dependents of fallen servicemembers.

MOAA will continue its work to remove hiring restrictions faced by retired servicemembers seeking some DoD civilian positions – removing the so-called “180-day rule.”

How We Can Help: Well the new session has started and every legislative effort must begin again through a process of sponsoring a bill, obtaining co-sponsors, and working through the various committees in both chambers. We need your help to make this happen. Help MOAA continue the fight on these ongoing issues, and ensure the upgrades that were included in the NDAA are carried out as intended by lawmakers, by signing up for our **Legislative Action Center**.

As you know we encourage all our members to use the **Legislative Action Center** when contacting their legislator regarding military related issues. A recent Military Officer magazine article devoted over ¾ of a page to the issue of growing our advocacy base, in addition to a full page explaining why it is so important to increase the number of members participating in advocacy actions. It was made clear that the current membership of 360,000 MOAA members have only yielded 20,000 members who have signed up for the **Legislative Action Center**. The best carriers of the message dealing with military benefits are veterans or those who have served alongside veterans. We are a small chapter but I am confident that we can contribute greatly despite our size.

Chapter Due\$ - Cheddar Up

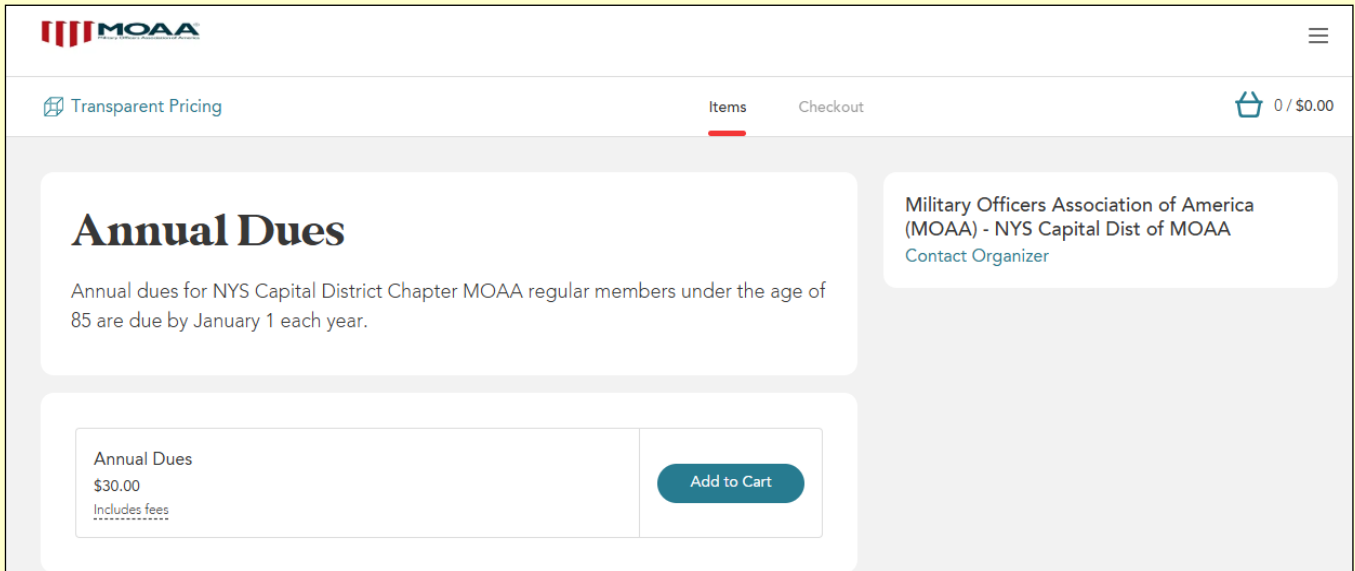
Dues for 2025 became due on January 1, per Chapter by-laws. Annual dues are **\$30**. All *regular* Chapter members *under the age of 85* are required to pay in order to remain a member in good standing. Surviving spouses of regular members do *not* pay dues. We will notify any members of their delinquency who haven’t paid their dues by the 90th day after January 1st (i.e., March 31st).

We have *three* options for paying dues: Paying by cash or check at a Chapter meeting, mailing a check to the Chapter PO Box, or paying online. MOAA has contracted with a provider to offer Chapters a *new* online portal through which Chapter members may pay dues: **Cheddar Up**. Unlike the previous online payment mechanism that MOAA maintained on its website, Cheddar Up resides on the provider’s site and Chapters have our own pages and accounts. MOAA is handling all fees, but we have permissions to create and manage our own money collection “mechanisms” and page displays. Chapters invite their members via a link or QRC to access one or more collections specific to the chapter – you *don’t* have to go through the MOAA website.

Our Chapter set up our dues payment function in December and tried it out to learn first-hand how it works. We’ve collected three payments successfully since then and confirmed that it’s ready for you to use. You can access our link to Cheddar Up through our Chapter website’s Homepage (shown below), or directly from this newsletter by clicking on this link: [Dues - CDNYMOAA](#). Then click on the link under the first option (Online), which will open our Cheddar Up dues collection page, *as shown on the following page*.



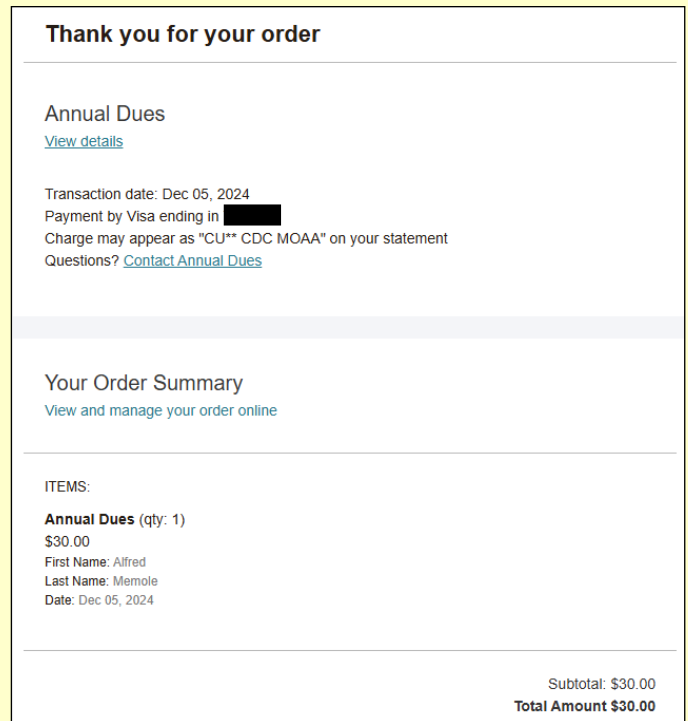

You pay dues the same way you shop online: *You add it to your cart and then process the payment at checkout.* The only difference is that the process requires you to enter your first and last names and current date. We added that requirement as an extra identifier, because Cheddar Up sends a notice to our Treasurer (Pat Piccirilli) and we want to be sure we know precisely who made the payment, not just the payer’s email address. *Also, we recommend that you pay only for the current year that’s due.* It makes it easier for us to keep track of who is paid up for the current year. After submitting your payment, Cheddar Up will send you an email confirming your payment (*example at right*).

We also created a collection for donations. We want to try that one out and experiment with a couple of options before it’s ready for prime time. We might make tweaks to the dues collection as time goes on and learn more about the system.

HIGHLIGHTED CHARITY for this issue → STRIDE'S ANNUAL WOUNDED WARRIOR SNOWFEST

STRIDE Adaptive Sports was set up to help children with disabilities to gain confidence and learn to overcome limitations through participation in sports and other physical and outdoor activities. The program soon began to include post 09/11 veterans recovering from war wounds, PTSD, or debilitating line-of-duty injuries in deployment. STRIDE seeks to speed the rehabilitation of these veterans through integrated adaptive sports and recreation activities. The main introductory or “gateway” event is the annual Wounded Warrior Snowfest, which STRIDE has been doing for two decades. STRIDE hosts up to 15 disabled veterans for a weekend of “skiing, riding and adaptive activities” with their families at Jiminy Peak Mountain Resort. The event kicks off with a dinner for the veterans and their families with STRIDE alumni veterans on Friday night before they head to Jiminy Peak for the weekend. Ultimately the STRIDE program strives to involve the disabled veterans in adaptive sports and recruit them into STRIDE’s Warrior community where the veterans serve in sports/outdoor programs for children with similar disabilities throughout the year or become mentors to them: healing through giving.

Our Chapter has supported the Wounded Warrior Snowfest, and continues to support it monetarily. [Please see the letter of thanks that the Chapter received, below.]

The **53rd Annual Convention of the New York State Council of MOAA Chapters** will be held in **Saratoga Springs 28 Sep-1 Oct**. The last time Council held its annual convention in the Capital District Chapter's area was 2017 at Lake George. This year's convention coincides with the 250th anniversary of the start of the Revolutionary War.
