## Our Last Meeting, April 12, at Norrine's Restaurant

We were honored to have as guest speaker **Mike Tagliafierro**, LTC USA RET, from the NYS Division of Military and Naval Affairs (DMNA). Mike described the changes that he observed throughout his military career serving in both active and, later, in the reserve components. He deployed to Iraq with the 42<sup>nd</sup> Infantry ("Rainbow") Division. He presented a vivid account of how the Army National Guard transformed itself from a state of low readiness during the Cold War, to the current high level of readiness and deployability today, making it a vital, integral part of our National Defense.



Chapter Board Member and President of the NY Council of Chapters, Skip Bebernitz reported on MOAA's recent Advocacy in Action activities in Washington, D.C., and gave an update on the NY Council of Chapters annual convention, coming this September in Saratoga Springs. He had Maj. Gen. April Vogel, USAF Ret., MOAA's VP for Government Relations (i.e., advocacy) lined up to attend, but a scheduling conflict forced her to decline.

## Board of Directors Meeting, April 26 at the NY Military Museum, Saratoga Springs

Chapter Board meetings follow a standard format where we review minutes from the last meeting, receive the Treasurer's report (we are financially solvent), and receive committee reports (Membership, Program, i.e., meetings, Newsletter, Website, Legislative Affairs, ROTC/JROTC Awards, Public Relations). Then we move on to continuing and unfinished business, such as By-laws, insurance, recruiting, potential grants, meeting schedules, advocacy, and community service. Lastly, the Board brings up and discusses new business.

The overarching take-away from this meeting was that our Chapter is performing well across the board, however, we need to find a way to increase attendance at our regular membership meetings and also recruit more members. A few specific developments that should be of interest to all Chapter members are:

1. **Approved donations for 2025** totalling \$850, with \$100 for STRIDE Wounded Warrior Snowfest, Veterans & Community Housing Coalition of Saratoga County, Capital District Women Veterans, Veterans Miracle Center, Toys For Tots, Friends of Grant Cottage, and Friends of the NYS Military Museum, plus \$150 for the LTC Todd Clark Memorial Tournament.
2. **Acquisition of liability insurance** to cover Chapter officers and directors for 2025. The Chapter has never been insured, so this is a first. The Board is looking at possibly obtaining general liability insurance, if we can find affordable coverage. Besides protecting the Chapter's financial assets from lawsuits should they occur, such coverage is required in order to qualify for MOAA community service grants needed to fund community service initiatives.
3. **Moving the luncheon meeting scheduled for October 4 to a date later in October**, probably the 25<sup>th</sup>. The Board decided that the 4<sup>th</sup>, picked last August, was too close to the NY Council of Chapters Convention, which ends on October 1, a situation that might depress attendance more than usual.

After the meeting, the Board did something that it rarely if ever did: We shuffled down and across the street from the NYS Military Museum to have lunch at *The Parting Glass*, an Irish style pub. And a fine time was had by all, as you can see from the photo to the right, taken by Vince Memole (not pictured). ## Legislative Affairs Committee Report

(Submitted by Pat Piccirilli, Legislative Affairs Committee)

MOAA representatives discussed ongoing concerns in key areas during a recent meeting with professional staff from both the House and Senate Armed Services Committees, part of our work to protect service-earned benefits in the face of budget constraints and a compressed congressional calendar. The talks covered **four key areas** of the six that were part of this year's Advocacy in Action campaign. These four key areas are: [unaccompanied housing](#), [military spouse employment](#), military health system (MHS) [access to care](#), and veterans [exposed to toxins while in uniform](#).

Professional staff on both committees characterized the year ahead as primarily defensive, with limited opportunity for advancing new legislative priorities. They expressed the greatest openness to efforts reinforcing or improving existing policies — particularly in areas related to DoD health care. Other issues, such as unaccompanied housing and military spouse employment, were met with interest and constructive discussion, though committee staff acknowledged constraints that may limit broader legislative action this year. Here's a look at what was discussed in the March session, and how you can keep up with progress on these critical issues:

### Unaccompanied Housing

MOAA and committee staff discussed the potential impacts of the [continuing resolution](#) on planned unaccompanied housing improvements. Committee staff acknowledged the issue but noted that funding limitations and competing priorities may constrain options in the near term. While broader legislative movement on this issue may prove challenging this year, it remains a critical area in need of oversight.

**Military Spouse Employment** (H.R. 2033 Military Spouse Hiring Act). The following NYS House of Representatives are co sponsors: *Morelle, Lawler, Meng, and Malliotakis*.

MOAA highlighted ongoing challenges facing military spouses in the federal workforce, including barriers related to licensure portability and other employment obstacles. Committee staff expressed support and encouraged continued focus on the issue, noting potential opportunities to push forward bills like the Resilient Employment and Authorization Determination to Increase the National Employment of Serving Spouses (READINESS) Act.

MOAA continues its work in support of the Military Spouse Hiring Act, which would award a tax credit to businesses hiring military spouses. However, because this bill would involve changes to the tax code, it would fall under a different committee jurisdiction.

### Military Health System: Access to Care

Committee staffers encouraged MOAA to continue advocating for reliable MHS funding amid concerns that DoD is redirecting resources away from health care, impacting both readiness and the benefit itself by undercutting the direct care system. Committee staff requested feedback on recent MHS stabilization testimony and other legislative proposals. MOAA was also asked to provide draft legislative language for a digital access assistance platform, which is one of our Tier 1 priorities, and help clarify how much was saved through the [TRICARE pharmacy network reductions](#).

### Toxic Exposure

MOAA discussed recommendations from its [Ending the Wait initiative](#) and raised concerns about ongoing challenges to access service-earned care and benefits. Committee staff asked what specific problems remain unresolved and whether DoD is still failing to acknowledge certain exposure-related

conditions. MOAA and committee staff agreed it is critical to clearly identify what is still not working in these processes and what gaps may remain.

### A Steady Voice

As Congress faces a compressed legislative calendar and ongoing budget uncertainty, MOAA remains committed to engaging with lawmakers and staff to advance practical, achievable improvements for the uniformed services and veteran communities. Even in a constrained environment, opportunities remain — and MOAA will continue to serve as a trusted voice, providing thoughtful policy recommendations and amplifying the concerns of those who serve and have served.

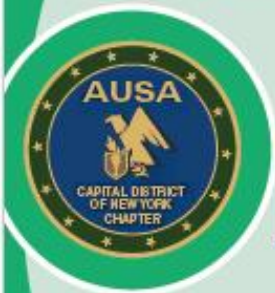

## BOOK REVIEW – COUNT DOWN 1960: 312 Days That Changed American Politics Forever

**Authors:** Chris Wallace and Mitch Weiss; 395 Pages

A very interesting book showing some of the behind the scenes events of both campaigns for JFK and Richard Nixon as they ran for the Presidency in 1960, an election that the MAJORITY OF HISTORIANS now say was indeed rigged.

The book is written in chronological order starting on January 2<sup>nd</sup> 1960, the day JFK announces his intention to seek the Democratic nomination for President of the United States, 312 days before Election Day, and ends on January 20<sup>th</sup> 1961, Inauguration Day. In between, the reader follows both campaigns; from JFK's announcement in Washington, DC, to Richard Nixon's arrival in Miami, Florida, on January 16<sup>th</sup> in the early morning hours before his first big campaign fund raising event.

The authors not only cover the very first live television debate and all the history that surrounds that debate, but also the other two debates rarely mentioned today. Also discussed are the dirty back room politics of how LBJ became JFK's running mate. The "Rat Pack" is mentioned many times (yes this youngster, coming from a very talented family of singers and musicians, knows who the "Rat Pack" is), but also mentioned are the issues of segregation and the coming of the Civil Rights era.

For those who like "juicy", yes, there are chapters and sections that tell of JFK's many different girlfriends, all while his wife was expecting their second child. You will even read about both candidates' medical and mental health issues and President Eisenhower's lack of assistance to the Nixon campaign, as well as CIA plans for the invasion of Cuba that were leaked to JFK's campaign! The authors even tell us about the "financial assistance", both legal and not so legal, provided by JFK's father that helped his son win.

The end of the book on January 20<sup>th</sup> 1961 is known by all. What may not be known is that Richard Nixon, even as he is remembered today, was ahead of this time and most certainly before what Al Gore would do in December 2000, and conceded defeat for the good of the country even though many in his Party begged him not too.

I highly recommend this interesting, easy to read and fun book, especially if one wants to read something different about politics than the daily news we are all following today.
